

## GUIDELINES FOR USE OF GORE AUTHORIZED THIRD PARTY LOGO

W. L. Gore & Associates (“Gore”) owns many valuable trademarks that identify and distinguish our products from those of other companies. Gore's trademarks are well known to the end users and signify that Licensees are buying quality, state-of-the-art products from a company with a reputation for innovation, dependability, and integrity. Significant time, effort, and money have been spent in the research, development, and promotion of these products.

The Gore Corporate Logo set out below is also a registered trademark and is in accordance with internal guidelines solely used by Gore on its (Gore’s) products, promotional literature and business papers.



Thus, the Gore Corporate Logo is not available to third parties, including companies with a commercial relationship with Gore. However, in order to enable Authorized Third Parties (distributors, agents, value added resellers and other companies in commercial relationship with Gore) to identify themselves as Gore’s Authorized Third Party on the market in a visually appealing way, Gore permits the use of the Authorized Third Party Logo as set out in Appendix A and according to the following guidelines:

### 1. Proper Use of the Authorized Third Party Logo

The Authorized Third Party will only use the Authorized Third Party Logo to identify itself as a Authorized Third Party. The Authorized Third Party will use the Authorized Third Party Logo only in association with the sale and distribution of Gore products. Electronic artwork for the Authorized Third Party Logo is available upon request. Any change in the Authorized Third Party Logo, except scaling for size, as well as employment of the Authorized Third Party Logo directly on a Gore product or its packaging is subject to Gore’s prior written approval.

All use of the Authorized Third Party Logo shall be accompanied by the following ownership designation in no less than 4 point type size:

“GORE® and designs are trademarks of W. L. Gore & Associates.”

The License expressly includes the right of the Authorized Third Party to use the Authorized Third Party Logo in its advertising and promotional materials. Gore will provide the Authorized Third Party additional product information and marketing material for integration into the Authorized Third Party’s own promotional literature. Such information and material cannot be modified, and the Authorized Third Party shall make no claims or representations with respect to the Gore product line and the performance or quality thereof with the exception of such claims or representations as are set forth in the information and material provided by Gore. Studies provided by Gore will be clearly identified as Gore product information and may not be used with the Authorized Third Party’s own logo.

## 2. Improper Use of the Authorized Third Party Logo

The Authorized Third Party Logo will never be used for the promotion or sale of products or services that are not Gore's products or services. The Third Party is expressly prohibited from ever using the Gore Corporate Logo apart from the Authorized Third Party Logo. The Authorized Third Party Logo will never be used in any manner that may cast a negative light on Gore or any Gore product or service. In the event of any use of the Authorized Third Party Logo contrary to these guidelines Gore reserves the right to immediately terminate the Authorized Third Party's agreement and license to use Gore's name and trademark and also the right to take appropriate legal action.

## 3. Scope of License

This document constitutes a limited, non-transferable, non-exclusive license whose sole purpose is to control the use of the Authorized Third Party Logo. No other rights are provided hereunder, including no license to use any other trademark or designation of Gore. Any use of the Authorized Third Party Logo by the Authorized Third Party will inure solely to Gore's benefit. The Authorized Third Party agrees not to take any action inconsistent with Gore's ownership and rights in the Authorized Third Party Logo and to cooperate fully in Gore's protection of the Authorized Third Party Logo. The Authorized Third Party agrees that it will never adopt a trademark or other designation that is identical or similar to the Authorized Third Party Logo or any element thereof.

## 4. Term and Termination of This License

This license terminates automatically once the Authorized Third Party ceases to be an Authorized Third Party for Gore. In the event of a breach of any term of this license by the Authorized Third Party, Gore may immediately terminate this license. Once terminated, the Authorized Third Party will cease all use of the Authorized Third Party Logo and destroy all copies of any product or material in its possession or control containing the Authorized Third Party Logo.
